### **FOCUS :**

The program will focus on interactive discussions and field visits to the stakeholders, commercial banks, agent banks and other related parties that practically support the success of the Indonesian National Strategy of Financial Inclusion.

### **PARTICIPANTS :**

The program may be attended by male or female senior or middle management officer from the government or private bank, other financial institutions, cooperatives or other agencies which may be directly or indirectly involved in crafting financial inclusion programs and strategies in their respective organizations.

### **SCHEDULE & VENUE :**

The program will be held in Jakarta, Bandung, and Bali, Indonesia from June 24 - 29, 2019 [6 days, excluding travel time].

### **TRAINING FEE :**

The training fee is only USD 1,490.00 per participant, which includes lunches, local transfers (airport reception, send off, executive train ticket from Jakarta to Bandung, one way domestic air ticket from Bandung to Bali, field visits, cultural exposure), facilitator's fees, training materials and supplies and other administrative costs.

The fee does not include international roundtrip airfares, hotel accommodation and other incidental expenses. These will be for the account of the nominating institution. APRACA CENTRAB will accept training fee remitted through telegraphic transfer.


